## PUBLIC NOTICE FOR SPONSORSHIP OF

### PAINTING EXHIBITION

## TIGRIS: THE QUEEN OF WILDLIFE

*Kolkata, 17th-25th September 2022*

#### 1. Purpose

The Consulate General of Italy in Kolkata wishes to organise a painting exhibition dedicated to the Royal Bengal tiger, to be held from 17<sup>th</sup> to 25<sup>th</sup> September 2022 in a renowned art gallery of Kolkata. The exhibition will feature a series of paintings by Italian artists Maurizio Boscheri and Daniel Calovi, which will be inaugurated on Saturday 17<sup>th</sup> September at the presence of numerous prominent figures from Italian and Indian business and cultural communities, authorities and also Italian citizens residing in India. During the exhibition, a series of art workshop will be organised for the benefit of students of different art schools of the city, as well as a seminar on the conservation of the Royal Bengal tiger.

#### 2. Scope of the sponsorship

For the programme as explained in point 1, which will be held from 17<sup>th</sup> to 25<sup>th</sup> September 2022, **the Consulate General of Italy in Kolkata** would like to grant – to a maximum of 3 entities – the possibility to participate as:

- a) **“Gold Sponsor”**: by a financial contribution starting from INR 300.000 (3 lakhs);
- b) **“Platinum Sponsor”**: by a financial contribution starting from INR 500.000 (5 lakhs).

The selected subjects/entities will be provided with advertising opportunities and visibility as follows:

- a) **“Gold sponsor”**: logo on the “invitation card” sent to all invitees for the inauguration + logo on the banner placed within the premises of the exhibition;
- b) **“Platinum sponsor”**: logo on the “invitation card” sent to all invitees for the inauguration + logo on the banner placed within the premises of the exhibition; + 20 invitations for clients/suppliers/employees with prior intimation about the same.

The exhibition and the different related programmes will be held at a prestigious art gallery in Kolkata and is expected to be attended, in its different segments, by around 180 invitees and advertised across all the official social media of the Consulate General.

#### 3. General Requirements for sponsorship applications

All private and public companies, enterprises, associations, foundations and any Italian or foreign entities, who does not undertake any activity in conflict with public interest, are invited to present their bids.

#### 4. Terms and conditions, and method of presenting bids

Interested parties must submit their bids within **8<sup>th</sup> August 2022** by email to [kolkata.congenerale@esteri.it](mailto:kolkata.congenerale@esteri.it), or by post / hand delivery to the Consulate General of Italy, 5G, Rev. Lalbehari Shah Sarani (formerly New Road) Alipore. Kolkata 700027.

The attached bid form should be filled in, duly signed, and should have the following information:

- The identity details of the proposer and/or registered name of the company/association/foundation;
- the type of sponsorship selected with indication of the financial contribution to be made;
- a declaration of having full understanding, and of complete and unreserved acceptance of the sponsorship conditions of this notice;
- attestation of non-existence of prejudicial or restrictive conditions for contractual capability as per the provisions of Art. 80 of Legislative Decree No. 50/2016.

#### **5. Evaluation of the bids**

The sponsorship bids will be evaluated on the basic principle of the highest bid or that which is economically most suitable or considered qualitatively viable.

The Consulate General of Italy shall evaluate the sponsorship for a maximum of 10 subjects/entities.

The sponsorship bids are, however, not binding upon the Consulate General till the signing of the concerned contract.

#### **6. Right to reject**

Please note that bids of the following nature will not be considered:

- a) Political, trade union related, religious, philosophical propaganda.
- b) Those that may contain offensive, fanatical, racist, hateful or threatening messages, and also those which are not in agreement with the laws and principles of the Italian legal order.

#### **7. Finalisation of the sponsorship contract**

Following the intimation regarding the acceptance of a bid, the contract will be finalised which shall govern the relations between the Sponsor and the Consulate General. In accordance with the decided schedule and methods, the Sponsor will provide its logo or brand, and/or provide to pay the financial contribution.

In case the event, for causes not under the control of the Consulate General, doesn't unfold, the parties shall jointly decide the mode of refund in case of any completed payment on the Consulate General's account.

It is necessary to consider the Art. 6 subparagraph 2 of the Decree of 2<sup>nd</sup> Nov. 2017, N. 192 (Collaboration with Private Entities), defining that in sponsorship contracts a particular clause should be included related to the right of withdrawal due to foreign policy, upon simple request, without any condition or restriction, free of charge and without prejudice to the right of refund of any advance paid and above the amount of services already provided. In case the prospective sponsor refuses to accept the clause, the contract of sponsorship shall not be valid.
